Preamble

GEM Enviro Management Ltd. - To promote the realization of environmental sustainability and development through core business and through participation in other multi-stakeholder activities as appropriate.
- To uphold the highest standards in business ethics and integrity and where appropriate, to support efforts of national and international authorities to establish and enforce such standards for all businesses.

5. GEM's Human Rights Statement

GEM is committed to developing a company culture that implements a policy of support for the internationally recognized human rights contained within the Universal Declaration of Human Rights and seeks to avoid complicity in human rights abuses.

Key human rights issues are embedded in internal risk assessment processes and guidelines, as well as addressed explicitly in other documents like Supply Chain Policy, Supplier Code of Conduct & ESG Policy.
